CONTRACT FOR INVESTIGATIVE SERVICES

For services rendered, I, _____, hereinafter referred to as "client," hereby contract Cat's Eye Private Investigations to conduct the type of investigation necessary to benefit and to assist in recovery of lost or stolen property, investigation of domestic issues, and help to disprove claims client may deem unjust against them. I agree to assist with the investigation to the best of my ability, and as I understand that Cat's Eye Private Investigations is not responsible for the results or outcome of my case, I agree to abide by the terms herein regardless of such outcome

Let it be known by all persons that Cat's Eye Private Investigations will investigate to the best of their powers, ability and/or knowledge any persons, firm or organization that the client has claims against, be it civil or criminal in nature.

For the above-mentioned services, the client hereby agrees to:

- Pay the sum of \$ _____, as a non-refundable retainer.
- Pay \$70.00 per hour (2 HOUR MINIMUM) and \$0.55 cents per mile (per investigator), including travel time, and an increased hourly fee of \$110.00 on holidays; the mileage fee will not vary.
- Remit additional retainers as needed, should expenses exceed the amount of the original retainer, in order to maintain a sufficient account balance as long as additional services are requested.
- Pay an administrative fee of no more than \$100.00 for an investigative report and video CD.
- Pay all expenses, where applicable (i.e. airfare, car rental, hotel, mileage, phone calls).
- Not base the total fee or remittance of said fee on the outcome of the investigation.
- Pay an investigator fee of \$70.00 per hour for any court appearance or testimony that may be required. There will be no charge for mileage and parking fees.
- Pay the invoiced amount within 15 days of the date of invoice. On "Past Due" Accounts, Cat's Eye Private Investigations retains the right to add a service charge of 1.5% per month to the unpaid balance.
- Pay the bill in the full at the request of Cat's Eye Private Investigations.

The client will be furnished with an investigative report at the end of the investigation. The client understands and agrees that the written report and videotape, if obtained, will be given to the client when the outstanding balance of the bill is paid.

If the client is untruthful with any information pertaining to this matter, this contract shall immediately become invalid, no money shall be refunded to the client, and payment shall be required in full.
